OFFICE MEMORANDUM

Sub:- Central Civil Services (Revised Pay) Rules, 2008 – Revised instructions for payment of 15(fifteen) months arrears w.e.f 1/1/06 to 31/3/2007 to the State Govt employees.

1. Please refer to this Department's Office Memorandum of even number dated 27th February, 2009 regarding disbursement of 6(six) months pay arrear for the period from July 2008 to December 2008 on account of implementation of the Sixth Central Pay Commission for the State Govt. employees.

2. In addition to the above, the Government of Arunachal Pradesh has now decided to release the remaining 30(thirty) months arrears to State Govt employees in the following manner:-

- (i) Arrears for 15(fifteen) months for the period from 01-01-2006 to 31-3-2007, would be paid in cash immediately.
- (ii) The remaining 15(fifteen) months arrears for the period from 1/4/2007 to 30/6/2008 would also be released before 31st March 2010, for which separate instructions will also be issued.

3. The expenditure is to be met from the budgetary provisions under Non-Plan/Plan head of account of concerned Departments for the financial year 2009-10. All Deptts, immediately after drawal of arrear, may intimate the actual amount drawn and disbursed to FD(Budget) of Plan & Non-Plan separately.
