Sub:- **Temporary enhancement in delegation of Financial Powers for Assembly Election-2009.**

In order to facilitate immediate disposal and concurrence of election related urgent expenditure, the Governor of Arunachal Pradesh is pleased to enhance the financial sanctioning powers in respect of the following authorities in partial modification of existing O.M No. FIN/B/20/76 dated 3rd April, 1995 readwith order No. FIN/E-13/1986 dated 1st March'1999, with immediate effect:-


1. **Secretary/Commissioner (Finance)**
Financial Sanctioning power enhanced from Rs. 2 lakhs to Rs. 25.00 lakhs in each case of election related expenditure of election Department under Major Head of Account 2015 – election under Demand No.4 (Non/Plan).
2. **Chief Electoral Officer-cum Secretary/Commissioner(Election)**
 - (a) Expenditure sanctioning power with the concurrence of finance Department enhanced from Rs. 15.00; lakhs to Rs. 25.00 lakhs in each case under Major Head -2015-Election, Demand No 4 (Non/Plan).
 - (b) Financial Sanctioning power enhanced from Rs. 40,000/- to Rs. 2.00 lakhs under Major Head 2015-Election, Demand No 4 (Non/Plan).
3. **Deputy Commissioner-cum District Election Officer.**
Financial Sanctioning Power enhanced from Rs. 15,000/- to Rs. 1.00 lakh in each case under Major Head of Account 2015-Election, Demand No. 4 including authorization for drawal of money in A/C bill upto Rs. 1.00 lakh.
Further, Joint secretary (Finance Department) is nominated as Nodal Officer in the Finance Department to deal with Election related files expeditiously.
The above enhancement is purely temporary and will lapse after Assembly Elections 2009
